#### **Meetings and Public Education:**

- Attended (Alan) TAGD Spring Business Meeting May 27, 2020 Virtual Zoom Meeting
- Attended (Alan) Public Funds Investment Act Training Webinar (4 hrs) hosted by TAGD via virtual webinar May 28, 2020.
- Rules Committee met virtually to discuss and recommend amendments to the District Bylaws relating to public comment on June 3, 2020.

## **General Business:**

- All District staff members have taken the annually required cybersecurity training during May and have been certified for 2020.
- Staff members began collecting static water level measurements (late spring) June 4, 2020 from 162 monitoring wells.
- Planning continued (Megan) for virtual and in-person educational training sessions covering "Project Wet" for area school teachers. Sessions are scheduled for June 17 & 18 and July 22 & 23, 2020.
- Plans continue to be formulated with Texas A&M University and the City of College Station for the second Water Field Day in Brazos County.
- Purchased a one-year Zoom subscription and began setup and use of the virtual meeting space during the COVID-19 shutdown.
- Completed exempt wells in Brazos and Robertson counties were geo-tagged, photographed, and an inspection of surface completion conducted as completion notification occurred (submission of driller's log).

- Mailed all Certificates of Registration to well owners with recently located wells found in the TCEQ archived water well log database.
- Continued work with John Seifert to identify areally and spatially diverse wells within all eight aquifers for "DFC monitoring well" designation.
- All fees for 2019 "Permit Annual" and "Production Annual" invoiced water production have been collected.
- Invoiced all "Production Monthly" permit holders for 2019 water production.
- Continued locating wells based of archived well logs housed in the TCEQ database.
- Began reconciling identified wells with proper aquifer using the virtual bore tool going grid by grid through the entire district.
- Non-exempt permit holders continue to report monthly water production directly to the ArcGIS database.
- ArcGIS map/data program updating of exempt well locations and well data.
- Continued to expand District presence on social media platforms including Twitter and Facebook.
