Dear Mr. Day and Members of the Board:

On behalf of UW Brazos Valley Farm LLC ("Applicant"), LRE Water ("LRE") is pleased to provide you with this submittal requesting authorization to transport up to 49,999 acre-feet/year from the Simsboro Formation. The UW Brazos Valley Farm LLC ("BVF") currently owns 8,992.17 acres of land and holds operating permits for 15,483 ac-ft/yr that were granted by the Brazos Valley Groundwater Conservation District ("BVGCD" or "District") in 2019 (Permits No. BVDO-0254 to BVDO-0256), and for 34,516 ac-ft/yr that were granted in 2022 (Permits No. BVDO-0292 to BVDO-0304), for a total maximum annual combined non-historic use production amount of 49,999 ac-ft/yr.

The enclosed transport permit application, if granted, would authorize the transport and use of water from these wells for Agricultural, Industrial, Commercial, Municipal, and Public Supply purposes for use outside of the District and within Milam, Williamson, Bell, and/or Travis Counties.

LRE has prepared a Transport Permit Form with the required attachments in accordance with the requirements outlined in the BVGCD Rules 8.4 and 10.3 for Transport Permit Applications (Adopted September 10, 2020). We request the BVGCD review the enclosed information for approval of the transport permit application
