

General Manager seeks to amend these five (5) permits to correctly identify the aquifer of origin. The wells were originally permitted as originating in the Queen City Aquifer. During the renewal process it became apparent they had been incorrectly classified. Driller well logs and water level measurements were obtained to properly classify the wells. The information was presented to LBG-Guyton. It was determined the wells all originate in the Sparta Aquifer.

The recommendation of the General Manager is that the permits be amended to read Sparta Aquifer.


