<u>Item 5 – Contract Approval for 2019 Hydro-geological Services</u>

In October, the board authorized District staff to execute a contract for 2019 hydrogeological services with WSP, USA (formerly LBG-Guyton). There are number of things that have transpired since that time which the board needs to be made aware of:

- John Seifert retired from WSP, USA and began his own consulting firm.
- John was to continue doing our hydro work through a second firm that would contract with WSP. WSP would have done all the billing. All of the same people from past years would have been involved doing our work.
- WSP and the second firm could not come to an agreement on terms of the contract between the two.
- John Seifert is now going to take the lead with his own firm (Ground Water Consultants, LLC) and hire WSP as contractors to his firm. GW Consultants, LLC will do all of the billing. All of the same people from past years would still be involved.
- John has all of the insurance and necessary coverage to perform the work required on him.

The Board needs to execute a contract with GW Consultants, LLC to replace, or in addition to, the contract with WSP. The WSP contract could sit idle with no work being charged to it.

It is the recommendation of the General Manager that the District execute a contract with Ground Water Consultants, LLC (John Siefert) for 2019 hydro-geological services required by the District.

As requested, our firm is pleased to provide this proposal for general groundwater consulting services to assist the District as it performs its duties that are part of overall operations.
