## Item 7 – Ratification of Invoice for Demolition Services

The District closed on the purchase of the 213 S. Magnolia Street, Hearne, Texas property Tuesday, August 27, 2024. The General Manager had been in communication with five (5) companies to obtain cost estimates/proposals for immediate demolition of the building if the transaction were to occur.

Albo LLC became the prime candidate for the demolition project. Following conversations with the Building Maintenance Committee and the District's attorney, the General Manager moved forward with a contractual agreement with Albo LLC in the amount of \$65,500.00 for the demolition effort.

The District bylaws require that this agreement be ratified by the Board at the next scheduled meeting.

It is the recommendation of the General Manager that the contractual agreement executed with Albo LLC in the amount of \$65,500.00 for the demolition of the 213 S. Magnolia Street, Hearne, Texas building be ratified.
