## Item 5 – Contract to Repair Office Brick Wall

During the December 12, 2024 board meeting, the General Manager was authorized to execute a contract with Boenigk Masonry for repairing the western brick wall of the District Office in the amount of \$9,900 plus up to an additional \$3,000 to have the wall water-sealed.

- Boenigk Masonry bid the sealing of the wall and providing the sealant at \$10,000
- After negotiating with Boenigk, it was agreed that the District would provide the sealant and Boenigk provide the labor.
- The District can provide the product to seal the wall two (2) times (once now, once when a second application is needed) for approximately \$450.

It is the recommendation by the General Manager to execute the revised contract with Boenigk Masonry Inc. to repair and water-seal the western brick wall of the office with the District providing the sealant product.
