Well #9 – (**BVDO-0322**) Located at: N 30.804269° W 96.356142° 0.34 miles E of the intersection of FM 974 and FM 2776 in Brazos County. Total maximum annual production from the water well will be 1,879 ac-ft/yr at a maximum rate of 2,000 gpm for Public Water Supply use. The well will produce from the Simsboro Aquifer.
