Discussion and possible action on a response to the Texas Commission on Environmental Quality Petition for Inquiry filed by Mr. Curtis Chubb concerning Post Oak Savannah Groundwater Conservation District. **A motion was made by Tom McDonald, second by Kent Watson, to move that the District respond to filing the edited version that has been discussed by Monique Norman amicus to TCEQ. - (6) to deliberate the deployment or specific occasions for implementation of security personnel or devices.
