- **One (1) existing well for Knife River Corporation Well #3 (BVOP-0277)** located at N 30.61234072° W 96.47897341° 2.32 miles SW of the intersection of Goodson Bend Road and Texas Hwy 47 in Brazos County for Industrial use. Total maximum annual production from the well will be 150 acre feet. The well will produce from the Sparta Aquifer.

Discussion and possible action of the following **Drilling/Operating Permit Application:**

- **One (1) new well for Louise Grigsby Well #15 (BVDO-0216)** located at N 30.957939° W 96.755755° 4.03 miles W of the intersection of FM 1644 and Wildcat Bridge Road in Robertson County for Agricultural use. Total maximum annual production from the well will be 500 acre feet. The well will produce from the Brazos River Alluvium Aquifer. **A motion was made by Bill L.
