  - Three (3) existing wells for Jacob Bumpurs:

**Well #1 (BVDO-0234)** - Located at: N 31.28696994° W 96.37015087° 0.69 miles SSW of the intersection of FM 937 and Dogwood Creek Road in Robertson County. Permit holder seeks to amend the existing permit lengthening the permit term from one (1) year to five (5) years. The well produces from the Simsboro Aguifer.

**Well #2** (**BVDO-0235**) - Located at: N 31.28648894° W 96.36962725° 0.71 miles SSW of the intersection of FM 937 and Dogwood Creek Road in Robertson County. Permit holder seeks to amend the existing permit lengthening the permit term from one (1) year to five (5) years. The well produces from the Simsboro Aquifer.

**Well #3 (BVDO-0236) -** Located at: N 31.28594787° W 96.37012299° 0.76 miles SSW of the intersection of FM 937 and Dogwood Creek Road in Robertson County. Permit holder seeks to amend the existing permit lengthening the permit term from one (1) year to five (5) years. The well produces from the Simsboro Aquifer.

Two (2) existing wells for Dale Carpenter:

Well #2 (BVDO-0241) - Located at: N 30.856583° W 96.418747° 1.33 miles SSE of the intersection of Pryor Lane and Dunns Fort Road in Robertson County. Permit holder seeks to amend the existing permit lengthening the permit term from one (1) year to five (5) vears. The well produces from the Sparta Aguifer.

Well #3 (BVDO-0242) - Located at: N 30.859058° W 96.416000° 1.20 miles SSE of the intersection of Pryor Lane and Dunns Fort Road in Robertson County. Permit holder seeks to amend the existing permit lengthening the permit term from one (1) year to five (5) years. The well produces from the Sparta Aquifer.
