- 1. Discussion and possible action on the Minutes from the June 14<sup>th</sup>, 2012 Regular Board meeting. A motion was made by David Stratta, second by, Pete Brien to approve the Minutes for the June 14<sup>th</sup>, 2012 Regular Board meeting as presented. The motion passed unanimously.
- 2. Review and authorization of payments made for services rendered for the month of June 2012. A motion was made by Kent Watson, second by Stephen Boykin to approve the expenses for the month of June 2012 as presented. The motion passed unanimously.
- 3. Discussion and possible action on the following Drilling/Operating Permit Application:
  - A. One (1) new well for David T. Keeling & Mitchell Keeling. The well will be located at 1344 Harless Lane, Franklin, X., for a total of 60 acre/feet per year for agricultural irrigation, providing water for hayfield, livestock and household use on a 145 acre tract. The well will produce from the Calvert Bluff Aquifer. A motion was made by David Stratta, second by Tom McDonald to approve the Drilling/Operating permit application for David T. Keeling & Mitchell Keeling as presented. The motion carried with, one (1) Director, Pete Brien abstaining.

- 4. Discussion and possible action on the following Operating Permit:
  - A. One (1) existing well for Paul Siegert. The well is located on Hwy 6, ½ mile South from FM 2549 on left, Hearne, TX., for a total of 5 acre/feet per year for commercial use on a 350 acre tract. The well produces from the Queen City Aquifer. A motion was made by Pete Brien, second by Tom McDonald to approve the Operating permit application for Paul Siegert as presented with the stipulation that the water be used within the district and if that is not the case an amendment would be necessary. The motion carried with seven (7) votes, one (1) Director, Bryan Russ, opposed.

Monique Norman gave a brief overview of Groundwater Management Area 12's petition process of its adopted Desired Future Conditions (DFCs) and official approval by the Texas Water Development Board that the DFCs were reasonable on June 21, 2012. Chairman Beachy stated that the incorporation of the DFCs and Modeled Available Groundwater figures into the District's Management Plan would be discussed at a future Board meeting.
