- 6. Discussion and possible action on the following Operating Permit Amendments:
 - One (1) existing well (BV-DO-0019) for Fortex Grass known as Well #2. The well is located at N 30.684890° W 96.514929° 0.45 miles SSE of the intersection of FM 1687 and Sims Lane Cutoff in Brazos County. The well produces from the Queen City Aquifer. The applicant requests an increase in total maximum production of 0.896 acre feet/year to 1.00 acre feet/year. A motion was made by David Stratta, second by Bill Harris to amend the permit for 1.00 acre feet/year as presented to Fortex Grass. The motion carried seven (7) voting for and Mark Carrabba not voting.

- Two (2) existing wells (BV-OP-0020, BV-DO-0031) for Oak Grove Management, LLC known as Well #1 and Well #3. Well #1 is located at N 31.179122° W 96.489684° and Well #3 is located at N 31.172369° W 96.488801° in Robertson County. The wells produce from the Hooper Aquifer. The applicant requests aggregation of these two wells.
- A motion was made by Pete Brien, second by Tom McDonald to approve the permit amendment for aggregation of two wells in the Hooper aquifer as presented to Oak Grove Management. The motion carried seven (7) voting for and Mark Carrabba not voting.
- 7. Discussion and possible action on the following Operating Permit Applications:
 - One (1) existing well for Jerry Wall. Well #1 is located at N 30.856542° W 96.219982° 0.71 mile WNW of the intersection of Texas Highway 21 and FM 974 in Brazos County for a total of 150 acre feet per year for agricultural irrigation use. The well will produce from the Sparta Aquifer. A motion was made by David Stratta, second by Kent Watson to approve the one existing Operating permit for Jerry Wall as presented. The motion carried seven (7) voting for and Mark Carrabba not voting.
 - Three (3) existing wells for Carrabba Brothers. Well #1 is located at N 30.730781° W 96.391567°, Well #2 located at N 30.729912° W 96.393055°, and Well #3 located at N 30.730472° W 96.394257° 0.21 miles SW of the intersection of Rabbit Lane and Thurman Road in Brazos County for a total of 170 acre feet per year for agricultural irrigation use. The wells will produce from the Sparta Aquifer. A motion was made by Kent Watson, second by Stephen Boykin to approve the three existing wells and aggregate the wells from the Sparta aquifer as presented for the Carrabba Brothers. The motion carried seven (7) voting for and Mark Carrabba not voting.
 - One (1) existing well for Trend Gathering and Treating, LLC. BOA Plant Well #1 is located at N 31.284365° W 96.401279° 0.86 miles east of the intersection of Hilltop Lane and CR 479 in Robertson County for a total of 2 acre feet per year for industrial use. The well will produce from the Hooper Aquifer. A motion was made by Bill Harris, second by Pete Brien to approve one existing well for Trend Gathering and Treating, LLC as presented. The motion carried seven (7) voting for and Mark Carrabba not voting.
- 8. Discussion and possible action on the following Drilling/Operating Permit Applications:
 - One (1) new well for Sanderson Farms. Well #2 will be located at N 30.649367° W 96.416697° 0.98 miles WSW of the intersection of FM 2818 and Shiloh Avenue in Brazos County for a total of 0 acre/feet per year for industrial use. The well will produce from the Simsboro Aquifer. A motion was made by Pete Brien, second by Bill Harris to approve one new well for Sanderson Farms with zero (0) acre/feet as presented. The motion carried seven (7) voting for and Mark Carrabba not voting.

- 9. Discussion and possible action on the following Historic Use Permit Amendment:
 - One (1) existing well (BV-HU-0025) for Sanderson Farms known as Bryan Plant Well #1. The well is located at N 30.649589° W 96.417417° 1.04 miles WSW of the intersection of FM 2818 and Shiloh Drive in Brazos County. The well produces from the Simsboro Aquifer. The applicant requests the aggregation of this well with one new Simsboro well proposed by the applicant. A motion was made by David Stratta, second by Tom McDonald to approve the amendment for aggregation for one existing well for Sanderson Farms as presented. The motion carried seven (7) voting for and Mark Carrabba not voting.
- 10. Discussion and possible action on the following **Permit Renewals** and ratification of approval of the related hydrology studies associated with the original applications:
 - City of Bryan Well #18 (BV-DO-0003). A motion to approve the ratification of the hydrological study for the City of Bryan Well #18. The motion passed with six (6) voting for, David Stratta opposed, and Mark Carrabba not voting.
 - Wellborn Special Utility District OSR Well #2 (BV-DO-0014). A motion was made by Pete Brien, second by Tom McDonald to approve the ratification of the hydrology study for Wellborn Special Utility District OSR Well # 2. The motion passed with six (6) voting for, David Stratta opposed, Mark Carrabba not voting.

A motion was made by Stephen A. Boykin, second by Bill Harris for a Resolution allowing the BVGCD to be removed from the Groundwater Management Area 14 (GMA 14) membership and Desired Future Conditions (DFC) planning process and assigning the entirety of Brazos County to Groundwater Management Area 12 (GMA 12). The motion carried unanimously, with Mark Carrabba not voting.
- 6. Update, discussion, and possible action to study the feasibility of water conservation enhancement projects within the District. No action taken on this agenda item.
- 7. Discussion and possible action on providing the Texas Water Development Board (TWDB), with updated irrigated acreage and irrigated water use estimates for year 2012. A motion was made by Stephen A. Boykin, second by David Stratta, to accept the numbers and submit them to the Texas Water Development Water Board (TWDB). The motion carried unanimously with Mark Carrabba not voting.
