- **One (1) new well for C3-College Station, LLC** located at N 30.583463° W 96.336757° 0.23 miles SSE of the intersection of FM 2818 and Holleman Drive in Brazos County for a total of 22 acre feet per year for Industrial use. The well will produce from the Yegua-Jackson Aquifer.
- **One (1) new well for Gathan & Angel Reistino Farms, LP** located at N 30.784842° W 96.592543° 0.35 miles S of the intersection of FM 50 and Ottea Road in Robertson County for a total of 59 acre feet per year for Agricultural Use. The well will produce from the Brazos River Alluvium Aquifer.

2. Discussion and possible action of the following **Drilling/Operating Permit Applications:**

- **One (1) new well for C3-College Station, LLC** located at N 30.583463° W 96.336757° 0.23 miles SSE of the intersection of FM 2818 and Holleman Drive in Brazos County for a total of 22 acre feet per year for Industrial use. The well will produce from the Yegua-Jackson Aquifer.
