- **One (1) existing permit for Burnside Investments, LP- Well #10 (BVDO-0283)** located at N 30.91818878° W 96.31282056° 0.38 miles WSW of the intersection of Muse Road and Muse Cut Off Road in Robertson County for Agricultural use. Permittee seeks to amend the existing permit to extend the permit term from one (1) to five (5) years. The well produces from the Brazos River Alluvium Aquifer.

Permittee seeks to amend the existing permit to extend the permit term from one (1) to five (5) years. The well produces from the Brazos River Alluvium Aquifer.

- **One (1) existing permit for Union Pacific Railroad – Mumford 25 (BVOP-0236)** located at N 30.767230° W 96.592895° 1.05 miles WSW of the intersection of Watts Lane and FM 50 in Robertson County for Industrial use. Permittee seeks to amend the existing permit to extend the permit term from one (1) to five (5) years. The well produces from the Brazos River Alluvium Aquifer.
- **One (1) existing permit for Union Pacific Railroad – Mumford 69 (BVOP-0237)** located at N 30.839957° W 96.636555° 0.42 miles NW of the intersection of FM 1644 and US Hwy 79 in Robertson County for Industrial use. Permittee seeks to amend the existing permit to extend the permit term from one (1) to five (5) years. The well produces from the Brazos River Alluvium Aquifer.
- **One (1) existing permit for Union Pacific Railroad – Mumford 29 (BVOP-0238)** located at N 30.77092038° W 96.59162335° 0.95 miles W of the intersection of Watts Lane and FM 50 in Robertson County for Industrial use. Permittee seeks to amend the existing permit to extend the permit term from one (1) to five (5) years. The well produces from the Brazos River Alluvium Aquifer.
- **One (1) existing permit for Union Pacific Railroad – Mumford 107 (BVOP-0264)** located at N 30.755540° W 96.590250° 1.37 miles SW of the intersection of Watts Lane and FM 50 in Robertson County for Industrial use. Permittee seeks to amend the existing permit to extend the permit term from one (1) to five (5) years. The well produces from the Brazos River Alluvium Aquifer.
- **One (1) existing permit for Union Pacific Railroad – Mumford 91 (BVOP-0284)** located at N 30.755540° W 96.590250° 1.89 miles WNW of the intersection of Watts Lane and FM 50 in Robertson County for Industrial use. Permittee seeks to amend the existing permit to extend the permit term from one (1) to five (5) years. The well produces from the Brazos River Alluvium Aquifer.
- **One (1) existing permit for Union Pacific Railroad – Mumford 92 (BVOP-0285)** located at N 30.79505858° W 96.60353334° 2.35 miles NW of the intersection of Watts Lane and FM 50 in Robertson County for Industrial use. Permittee seeks to amend the existing permit to extend the permit term from one (1) to five (5) years. The well produces from the Brazos River Alluvium Aquifer.

The Bo Board of Directors may meet in closed session, pursuant to the Texas Open Meetings Act, Texas Government Code §§ 551.071-551.076, to:

- (4) to deliberate the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of a Board member or District employee;
- (5) to receive information from employees or question employees, but not deliberate public business or agency policy that affects public business; and
- (6) to deliberate the deployment or specific occasions for implementation of security personnel or devices.
